Mother Nature sure made October an exciting month for SC with Hurricane Matthew. I hope that everyone has been able to get back to life as normal after the storm. Thanks Dan for arranging yet another great presenter for us! Our attendance for the first two meetings of this year have been lower than normal for us. We have had some great presenters and I hate that some of our members have missed them! I hope that everyone will renew their commitment to being an active member; attending our meetings and taking advantage of the great benefits of being a part of the CCAL. Here are some of the key things happening in CCAL right now:

Juried Show: The dates have been set for this year's Juried Show. Delivery of artwork will be February 18-19. The awards reception will be on Monday, March 20 and non-awarded artwork pick up will be March 25. Remember that participation is open to members who have 1) paid their annual dues and 2) attended at least three meetings since March of last year. In response to numerous questions in prior years, the board adopted clarifying language following the model of the State Fair requirements as follows: "A Professional Exhibitor is defined as anyone who has earned \$1,000 or more during a calendar year by either selling their items, teaching the subject, doing extended exhibiting, or involving themselves in other professionally related activities in a capacity that would give the entrant unfair advantage over an amateur." Todd Baxter will be the juror for our show. You can learn more about Todd at www.baxterfineart.com. If you attended the State Fair this year you probably saw that Todd was the recipient of several awards there.

Publicity: Thanks to the hard work and organizational mastery of Claudia Zeigler, CCAL was an exhibitor at the First Annual Chapin Fall on October 15 at the Coffee Shelf from 9-5. Thank you so much to everyone that helped out! We are always looking for other PR opportunities for CCAL and its members so if you have any requests or recommendations for publicity, please let Claudia know.

"Let's Paint Chapin": As a reminder, Ann Peake has planned another fun yearlong activity for us all. "Let's Paint Chapin" will be a chance for us to paint some of the great historic houses, old filling stations, barns, churches, bridges, trees, old Chapin Theater, water towers, river/ponds, Chapin lake side scenes, old buildings, streets and faces of the community from Chapin, Prosperity and Little Mountain. Paintings, which must be no more than 8x10, are due by April 15th and will be first shown at the May

meeting. Winners will be selected by an impartial judge. I hope everyone is out there finding just the right iconic scene as inspiration an entry in this competition. If you have any questions about this special project, please contact Ann Peake.

Looking ahead

At our November 21st meeting, we have another great speaker: Amy Perrier from Hendersonville NC. She is an Acrylic painter that uses her fingers to paint. She will be doing a live demo during the meeting. Her website is amyperrerpaintings.com. In her own words, "My contemporary paintings are created by simply using my fingers as brushes. Occasionally, I will use graphite or a palette knife if I desire a hard edge or wish to reveal previously applied layers of paint. My inspiration comes from the world around me, both real and imagined. My passion to paint keeps me painting every day. The circles imprinted into the canvas [of her paintings] are an homage to my mother, artist Nancy Hunt. No longer painting due to illness, she still encourages me in my endeavors to be a contemporary artist. She gave me several jars of paints about 15 years ago that I have always treasured. As I paint in this interpretive style, I stamp the lid of one of her jars into the first step of my painting process; keeping her as well as her desire to be a contemporary artist, close."

The theme for the TAP gallery in November will be Winter Scenes. If you have some art to celebrate the season, please plan to hang it on the left side of the gallery. Since we will not be meeting at the park in December, any art in the Gallery can remain there until our January meeting. All sizes of paintings are welcome – bring some bigger pieces as well as some small if you have them. Even if you have some pieces that are not winter scenes you can bring them if you prefer so we can properly fill the space and showcase CCAL artists. The gallery is looking rather sparse right now so please consider making a trip to the park to hang something for all to admire. Our theme for January will be animals; dogs, cats, horses, birds, whatever strikes your fancy. So plan ahead!
